## Licensing in Macao

One of the frequent questions asked by clients when establishing business in Macao is that they are not sure of the licenses needed to undertake such business. In most of the businesses, there are no restrictions or constraints and license is not needed. However, some of the industries are required to apply for license before operations commenced. Businesses such as banks, construction companies, factories, hotels, restaurants and transportation operations, special licenses are required before the business commenced. There are difference requirements for applying different license.

Various government departments or bureau are responsible for different license applications. In the assessment and issuance process, the "Civil Procedural Code" was used as the guidance for handing the application. The table below listed the business activities which require special licenses and the respective administrative authorities for approval.
